#### Mr Eugene Seow

Mr Eugene Seow joined the NCSS Board in 2016 and will step down after serving four terms. He has contributed substantially to various Board committees such as the Executive Committee, Volunteer Resource Committee, Social Service Sector Strategic Thrusts (4ST) Strategic Review Panel, Human Capital and Organisation Development Committee, and Sector Capability and Transformation Committee.

#### **Profile of NCSS Board Members**

#### Ms Anita Fam

President

Ms Anita Fam, a former lawyer, is a full-time volunteer who has been involved in the social service sector for more than 20 years, both at charity and national level, in the areas of disability, palliative care, healthcare and mental health.

Anita currently serves as President of the National Council of Social Service, Chairman of the Inmates' Family Support Fund and Vice Chairman of the Board of Visiting Justices & Board of Inspection. She sits on various boards and committees including the Institute of Mental Health, Lien Foundation, SG Cares Steering Committee, Catholic Health Care Asia, and the Public Service Commission's Disciplinary Panel of Persons.

Also a Justice of the Peace, Anita was conferred the Public Service Star (BBM) (Covid-19) in 2021, the Public Service Star (BBM) in 2014 and the Public Service Medal (PBM) in 2008 for her work in the community.

#### Ms Theresa Goh

Vice-President

Ms Theresa Goh is the Managing Founder of 360 Dynamics. She is a strategic associate with the Centre for Creative Leadership and Global Coach Group. Theresa is a board member of the Agency for Integrated Care (AIC) (Ministry of Health), Chairperson of the Ministry of Culture, Community, and Youth (MCCY) Charity Council, immediate past Chairperson of SATA CommHealth and the Centre for Non-Profit Leadership. #### Clinical Associate Prof Kevin Lim

Clinical Associate Professor Kevin Lim is an orthopaedic surgeon with a subspecialty interest in paediatric orthopaedics and scoliosis. He currently serves as Director, Strategic Partnerships and Global Health at KK Women's and Children's Hospital. As an academic clinician, Kevin is active in clinical research and has

presented and published his work widely; he is reviewer and editorial board member for several medical journals. Kevin is also the Country Advisor (for Singapore) for the Royal College of Surgeons of England.

During his decade-long Chairmanship at Cerebral Palsy Alliance Singapore (CPAS), he played a pivotal role in setting up the national registry for cerebral palsy. Kevin continues to serve on the CPAS board as Emeritus Chairman and Advisor. At NCSS, he chairs the Services Committee, and serves as a member on the EXCO. Kevin has won several awards for service, teaching and research excellence; they include the Singapore Health Quality Service Award (Superstar), PS21 Star Service Award, Healthcare Humanity Award, NUS Dean's Award for Teaching Excellence, the SingHealth Publish! Award, and the SingHealth Outstanding Clinician Award. For his dedicated service to the social services and public healthcare, Kevin has been awarded the Public Service Medal (PBM), the Public Service Star (BBM) and the Long Service Medal (PBS).

#### Mr Chew Sutat

Community Chest Chairman

Mr Chew Sutat was appointed as Community Chest Chairman in 2022. He joined Community Chest as Vice Chairman in 2020. He has served on NCSS's Services Committee since 2020 and its Community Chest Committee since 2019. He is also the former chairman for Kaki Bukit Citizens' Consultative Committee (CCC) and its current Patron.

Sutat retired after 25 years in the financial services industry and continues to contribute as a volunteer in the social service sector and grassroots. He has leveraged his extensive network in the financial industry as former Executive Vice President and Senior Managing Director (Head of Global Sales and Origination) of Singapore Exchange (SGX) and Chairman of SGX Bull Charge to mobilise resources for the social service sector. Between 2016 and 2021, Sutat led SGX Bull Charge to fundraise a total of \$15.8 million for Community Chest. Sutat has also been instrumental in connecting listed companies and ultra-high net worth individuals to Community Chest.

As Chairman of Caregiver Alliance Limited (CAL), a position he held from 2015 to 2022, he has strengthened community awareness and its services in support of caregivers of people with mental health conditions. His association with CAL and grassroots organisations gives him a holistic view and familiarity with both the social service and public sectors, and he has been able to rally the private, public, and people sectors to contribute strategically to social services.

#### Ms Shahrany Hassan

Ms Shahrany Hassan is the Chairperson of Casa Raudha, a crisis shelter for women and children who are victims and survivors of domestic violence. Currently serving her second term, she is leading the organisation as it looks to expand its services from protection (providing shelter), to include both prevention (education and engagement) and restoration (providing support and resources).

Shahrany is actively involved in championing the rights of, and being the voice of, women and children who have suffered abuse. At the height of the pandemic, together with the Casa Raudha team, she led a successful campaign against domestic violence that reached over a million people online. She continues to create awareness on domestic violence on various media, through interviews, podcasts, and op-eds. Her work has earned mentions in Parliament and been featured numerous times in the media.

#### **Dr Teo-Koh Sock Miang**

Dr Teo-Koh Sock Miang has been active in the disability sports community for decades. She is currently the President of the Singapore National Paralympic Council, Singapore Disability Sports Council, and Special Olympics Singapore. Previously, she served as Vice-Dean of the School of Physical Education (PE),

Associate Dean for PE Programs and Head of the PE & Sports Science Department at the National Institute of Education (NIE). She was a Visiting Fellow at the College of PE, Recreation and Health, Indiana University in Bloomington, USA (from August 2004 to May 2005).

Sock Miang is a specialist movement consultant for movement programmes for preschool and lower primary children, including adapted PE programs for individuals with disabilities. She has been engaged by the Ministry of Education (MOE) to provide professional development courses in fundamental movement programmes to early childhood educators and special education educators. She is currently a consultant with MOE Special Education Branch, assisting to develop the PE curriculum for special schools. In 2024, Sock Miang was inducted into the Singapore Sports Hall of Fame.

#### **Mr Vincent Lim**

Mr Vincent Lim has been active in the Singapore Social Service sector since the early 2000s. He currently serves on the boards of HCSA Community Services and The Saturday Movement. He was the Board President of HCSA from 2015 to 2019. Vincent served in the NCSS Board since 2022.
